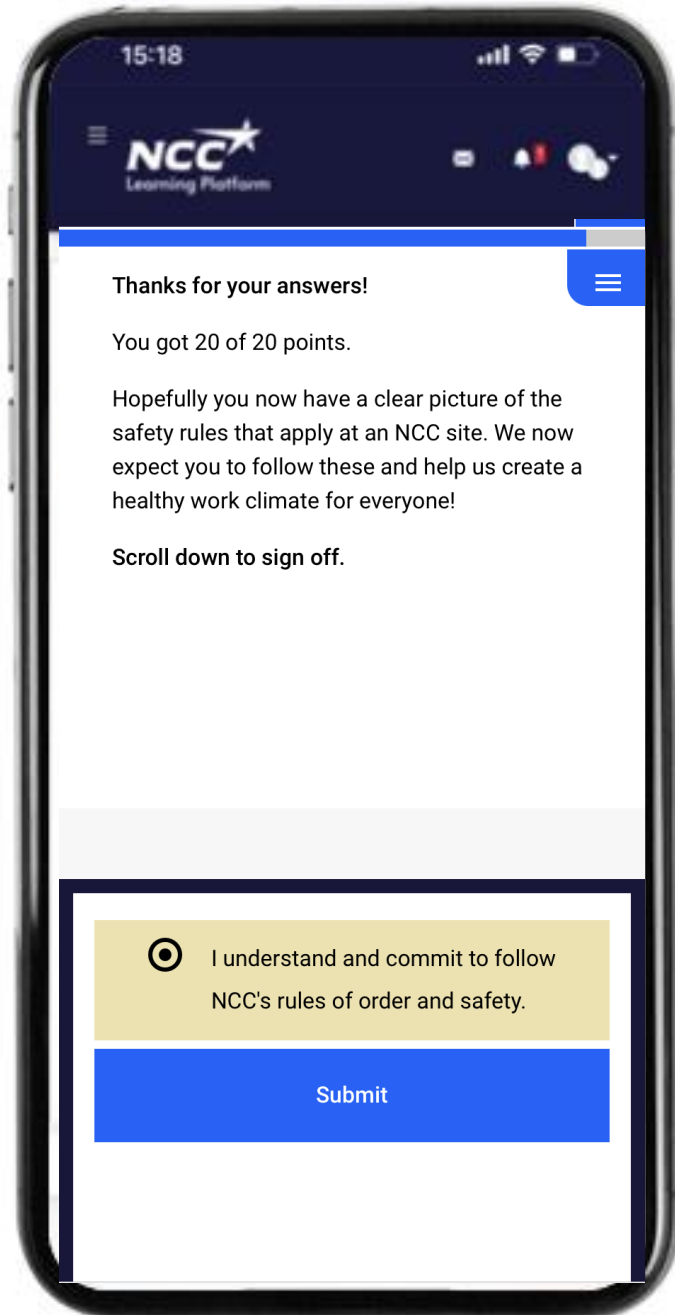




# Rules of order and protection as questions

- All 20 questions must be correct

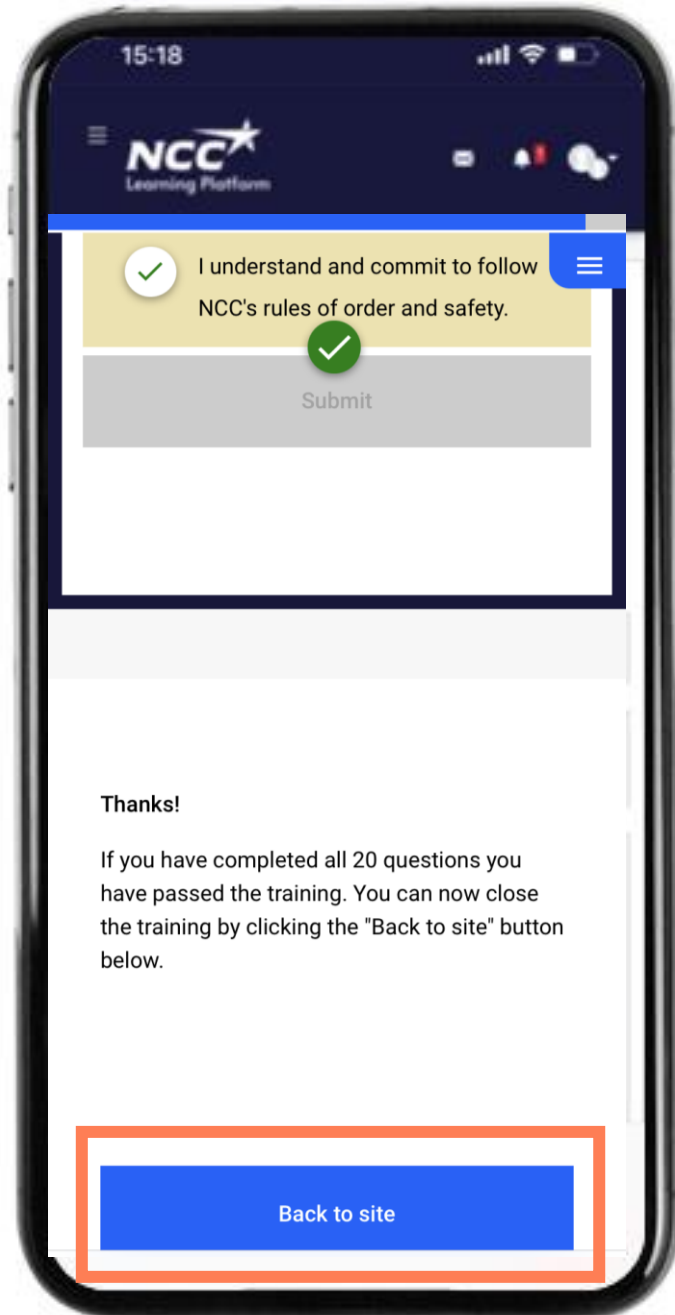

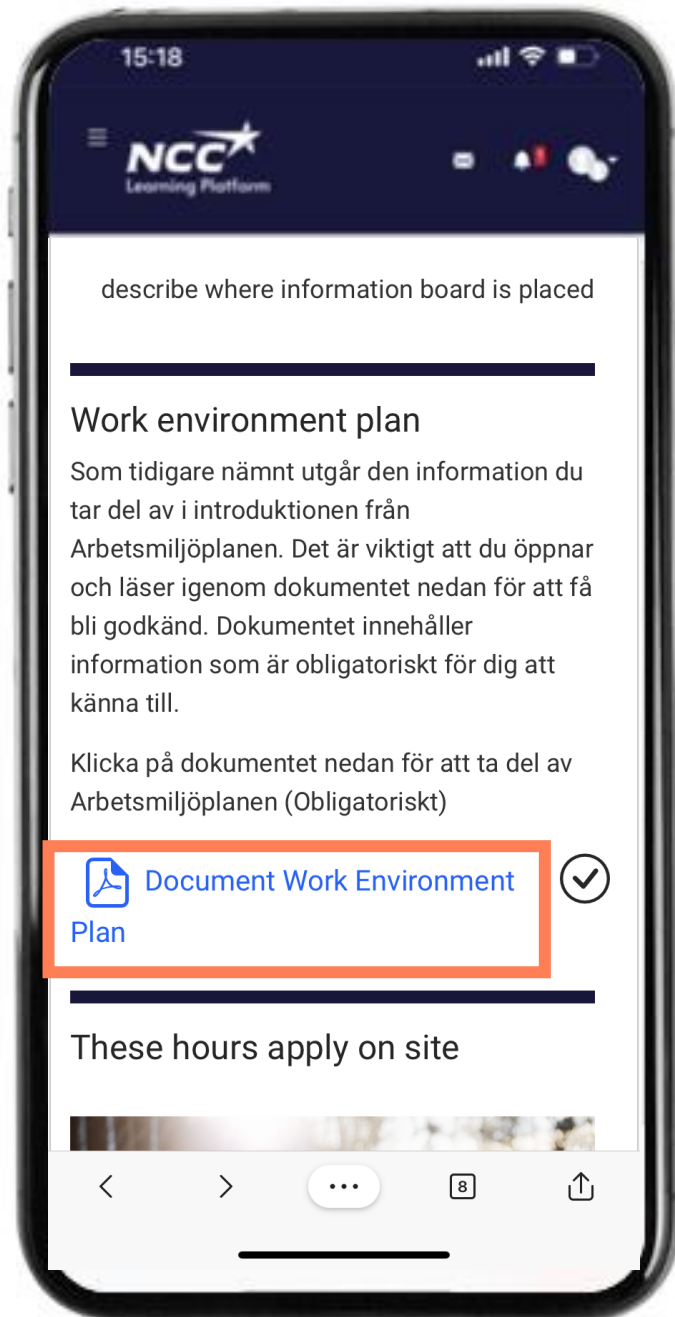

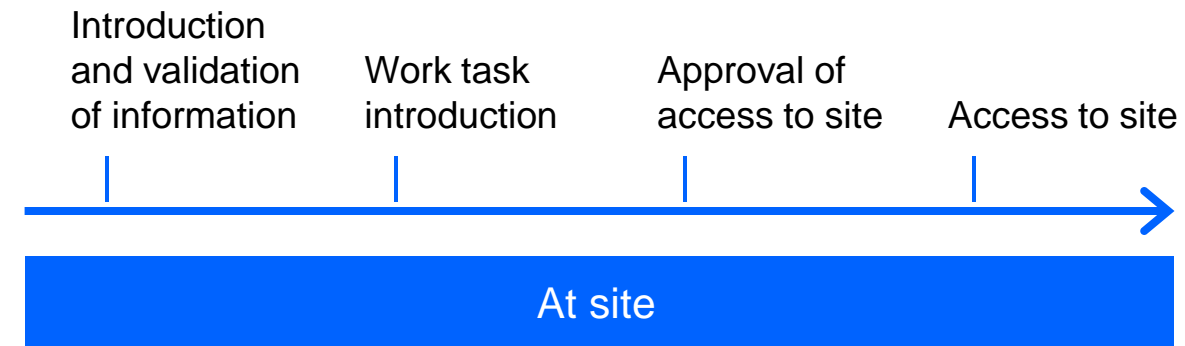

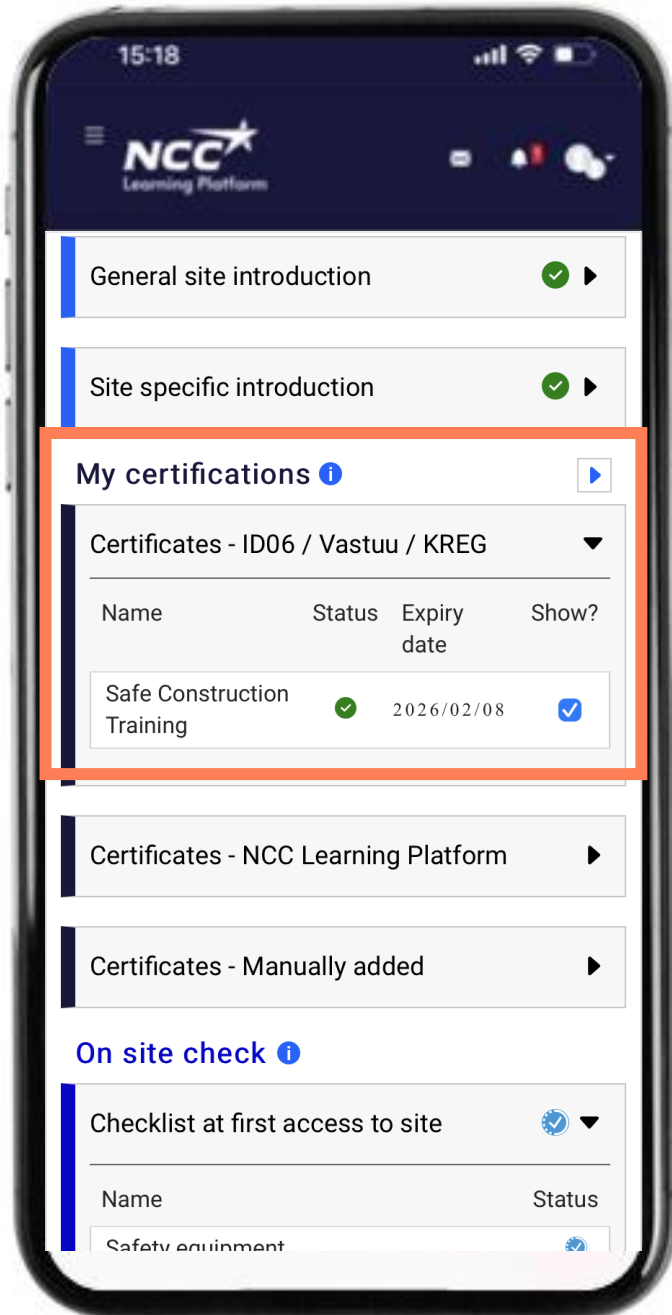

In Sweden, Safe Construction Training is mandatory at all sites and is therefore shown both in "mandatory training at this site" and under "my training"

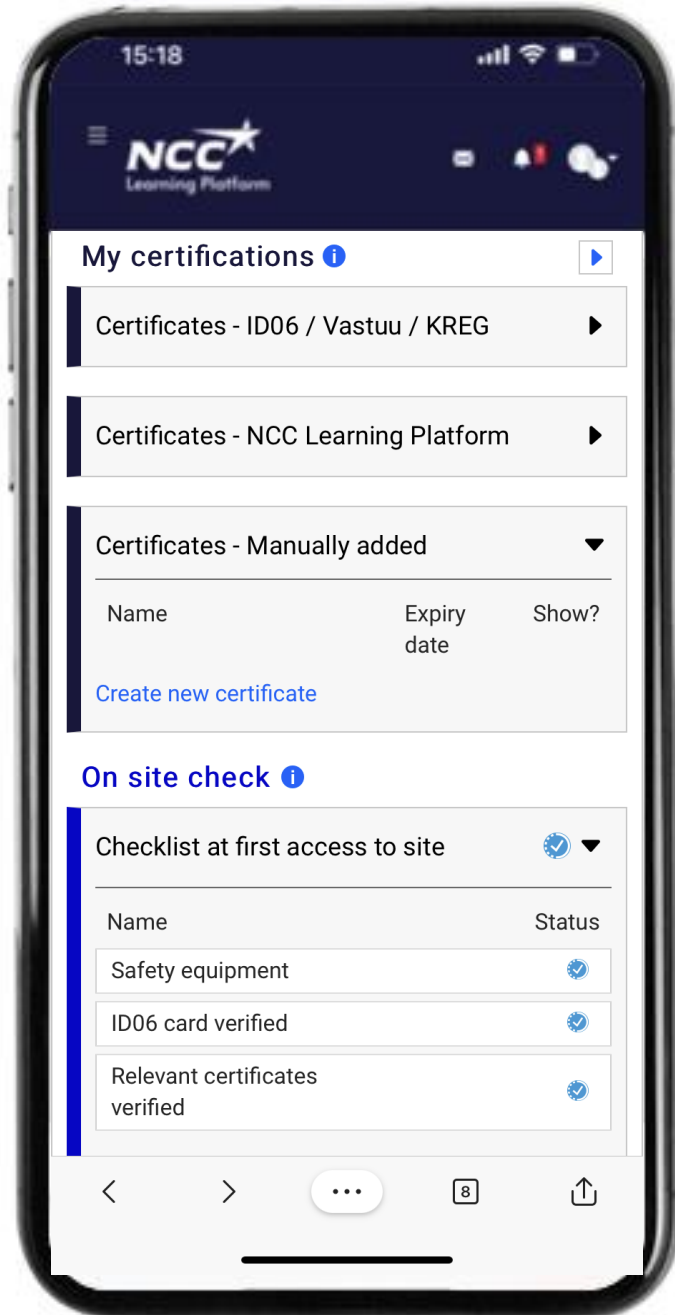

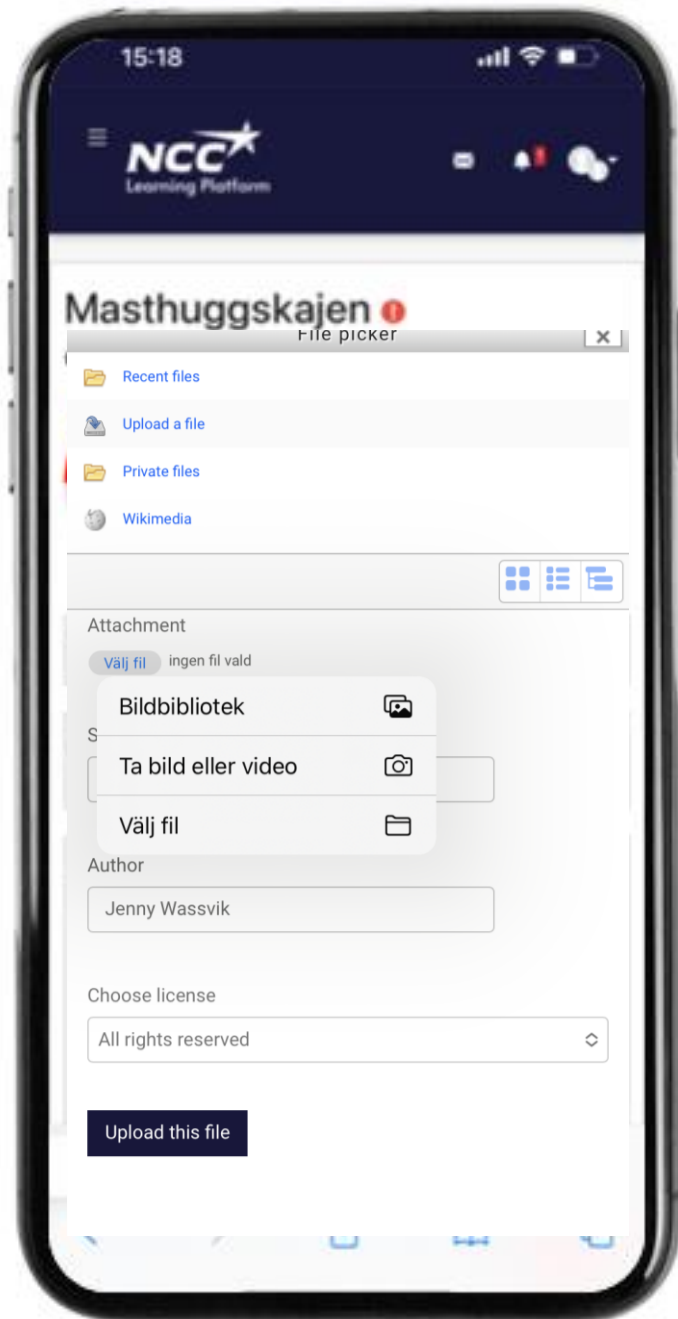

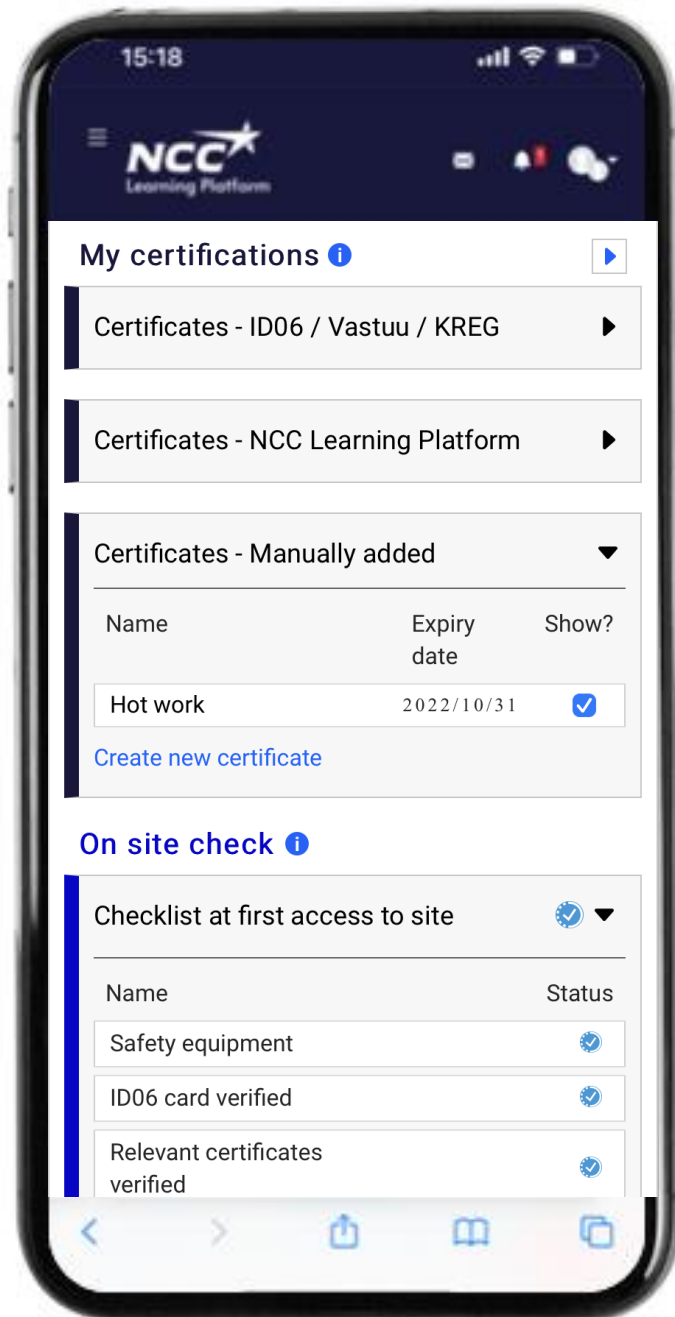

# Consent for registration

1. Go to [www.id06kompetensdatabas.se](http://www.id06kompetensdatabas.se)
2. Click on "Show my educations / Consent for registration"
3. Log in with Mobilt BankID
4. Under the Central Consent tab - select allow
